Objectives and Investment Policy           The Fund aims to produce positive returns with medium/high volatility (range and frequency of price movement).           The Fund is actively managed and is not managed in reference to a benchmark.           The Investment Manager has discretion over the composition of the Fund's portfolio, subject to the stated investment objectives and policies.           The main investment strategy of the Fund is to seek to identify and invest in companies that could benefit from trends, such as humanity (demographic trends, population growth/decline, immigration/emigration), low, mid, high business production cycles, economic developments (technological enhancements, internet, cloud computing) or country specific (gross domestic product growth rates). However, other investments could be made depending on the Investment Manager's assessment of the market.           The Fund may invest up to 100% of its net asset value (NAV) in equities and equity related securities whose currency unit is Euro, across all industries and all sizes of companies, mainly be listed on a Regulated Market (as defined in the Prospectus) in Europe.
