 The Fund is actively managed and is not managed in reference to a benchmark. The Investment Manager has discretion over the composition of the Fund's portfolio, subject to the stated investment objectives and policies. Investments could include fixed income and debt securities, such as bonds, senior notes (debt that takes priority over unsecured or more junior debt), subordinated debt (debt that ranks below other debt with regard to claim on assets or earnings), structured notes (a type of hybrid debt security which usually has a derivative component), certificates of deposit, medium term loan notes, asset and mortgage backed securities, collateralised debt and other debt instruments. These investments will mainly be issued or guaranteed by any OECD government and/or by corporate or other issuers like special purpose vehicles. The Fund may invest up to 10% of its net asset value (NAV) directly or in directly in global equity securities across a range of industries mainly through investing in convertible bonds (securities that give the holder the right to convert the bond into shares) and warrants (securities that give the holder the right to buy newly created shares at a fixed price during a set period).
