What is this product?

This is an investment fund established as an Open-Ended Unit Trust

Objectives

Investment objective We seek to grow the Fund (through increases in investment value and income) over a rolling 5 year period after deducting fees and costs.

Investment policies The Fund will invest in a broadly diversified global portfolio of securities, primarily including equities and debt securities traded on the main global Regulated Markets.

The Fund will employ a diversified strategic allocation approach, investing in debt securities to seek to produce a reasonable level of current income as well as investing in equities to seek to achieve long term capital growth and income growth for investors' future requirements.

The Fund may also hold and invest in money market instruments such as bank deposits, fixed or floating rate instruments.

The Fund may only use derivatives to maintain the Fund's value, manage investment risk and to gain cost-effective access to investments. Derivatives are financial contracts whose value is linked to the price of another asset (e.g. indices, rates, share prices, currencies).

The Investment Manager will assess securities for environmental, social and governance issues and consider Sustainability Risks to inform the security selection in the Fund.

Benchmark The Fund is actively managed and will not track an index.

Redemption and Dealing You can buy and sell units in the Fund before 12 noon GMT on any business day in Dublin.

Distribution Policy Any income due from your investment may be paid out to you.

Launch date The Fund was launched on 06/11/2018. The Unit Class was launched on 06/11/2018.

Fund Currency The base currency of the Fund is EUR.



What are the risks and what could I get in return?

Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that

Performance scenarios

What happens if the Fund is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depositary. Should we default, the depositary would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 EUR is invested.
