What is this product?

Type

This is an investment fund established as an Open-Ended Unit Trust.

Objectives

Investment objective We seek to grow the Fund (through increases in investment value and income) over a rolling 5 year period after deducting fees and costs with a lower risk profile than investing solely in company shares.

Investment policies The Fund will invest between 40% and 80% of the Fund in the shares of companies from around the world. It will also invest in fixed and floating rate, government and corporate bonds as well as convertible bonds or warrants. Such debt securities will normally have a minimum credit rating of BBB as rated by Standard & Poor's, Moody's or an equivalent credit rating agency.

It will also invest in units in funds (including those managed by Sarasin), cash and it even may hold up to 60% of the Fund in these assets when we deem it appropriate in order to manage difficult market conditions.

We carefully select the Fund's investments and have free choice to select companies from any country/region, sector or industry. We identify the long-term investment themes that drive growth and lead to disruption in global economies and industries, and will shape the world in which we live and invest. We select companies based on our own analysis of which are most likely to benefit from our themes, and are well placed to grow their revenues and cash flows as a result of them.

The Fund may only use derivatives to maintain the Fund's value, manage investment risk and to gain cost-effective access to investments. Derivatives are financial contracts whose value is linked to the price of another asset (e.g. indices, rates, share prices, currencies).

The Investment Manager will assess securities for environmental, social and governance issues and consider Sustainability Risks to inform the security selection in the Fund.

Benchmark The Fund is actively managed and will not track an index.

Redemption and Dealing You can buy and sell units in the Fund before 12 noon GMT on any business day in Dublin.

Distribution Policy Any income due from your investment may be paid out to you.

Launch date The Fund was launched on 01/01/1988. The Unit Class was launched on 15/10/2012.

Fund Currency The base currency of the Fund is GBP.

What are the risks and what could I get in return?

Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

Performance scenarios

What happens if the Fund is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depositary. Should we default, the depositary would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 GBP is invested.
