# What is this product?

This is an investment fund established as an Open-Ended Unit Trust.

#### Objectives

**Investment objective** The Fund seeks to achieve long-term capital growth though investment in the shares of global real estate companies and global real estate investment trusts.

**Investment policies** The Fund invests mainly in Real Estate Investment Trusts, and company shares from around the world, which are linked to the property market and may also invest in other closed-ended property related funds.

The Fund will hold mainly the shares of large or medium sized companies, but from time to time may invest in smaller companies. These companies will earn income from letting properties or land, and may also be involved in land development, which take ecological and social sustainability issues into account in their business operations.

Derivatives (financial instruments whose value is linked to the expected future price movements of an underlying asset) may be used only with the aim of reducing risk or costs, or generating additional capital or income.

**Benchmark** The Fund is actively managed and will not track an index.

**Redemption and Dealing** You can buy and sell units in the Fund before 12 noon GMT on any business day in Dublin.

**Distribution Policy** Any income due from your investment may be paid out to you.

Launch date The Fund was launched on 06/12/2004. The Unit Class was launched on 24/06/2020.

**Fund Currency** The reference currency of the Fund is GBP and the currency of the share class is USD.

# Risks

### **Performance scenarios**

# What happens if the Fund is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depositary. Should we default, the depositary would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

# What are the costs?

#### Costs over time
