# **OBJECTIVES AND INVESTMENT POLICY**

#### **Investment Objective**

The investment objective of the Fund is to seek to provide an attractive total return with a volatility lower than the US equity market by investing in U.S. companies with strong and growing free cash flow and which provide income and long-term capital appreciation. The Fund typically invests in a diversified (75-120 securities) portfolio of U.S. equity securities (e.g. companies' shares).

#### **Investment Policy**

The Investment Manager's stock selection process involves a detailed analysis of U.S. equity securities to select companies that generate consistent dividend growth and operating cash flow and possess management with consistent and successful capital allocation policies with a focus on generating returns for shareholders by paying dividends and through buying back shares or paying down debt without taking undue risks. The Fund can invest in U.S. companies across a range of market capitalisations and sectors.

The Fund is considered to be actively managed in reference to Russell 1000 Value Index (the "Benchmark") by virtue of the fact that it uses the Benchmark for performance comparison purposes. Certain of the

Fund's securities may be components of and may have similar weightings to the Benchmark. However the Benchmark is not used to define the portfolio composition of the Fund or as a performance target and the Fund may be wholly invested in securities which are not constituents of the Benchmark.

#### **Fund Currency**

The reference currency of the Sub-Fund is USD.

#### Income

Any income the Fund generates will not be paid out but will instead be reinvested to grow the value of your investment.


#### **Investment Horizon**

# **RISK AND REWARD PROFILE**

# Why is this Fund in this category?

# Are there any other particular Risks?

**Concentration risk** - the Fund's investments are concentrated in the US. This means the Fund may become more susceptible to fluctuations in value resulting from adverse economic or business conditions in the US. The Fund may be subject to a greater degree of risk and volatility than a fund following a more diversified.

**Investment risk** - the Fund invests in securities globally, share prices can rise or fall due to a number of factors affecting global stock markets.

## **CHARGES**


