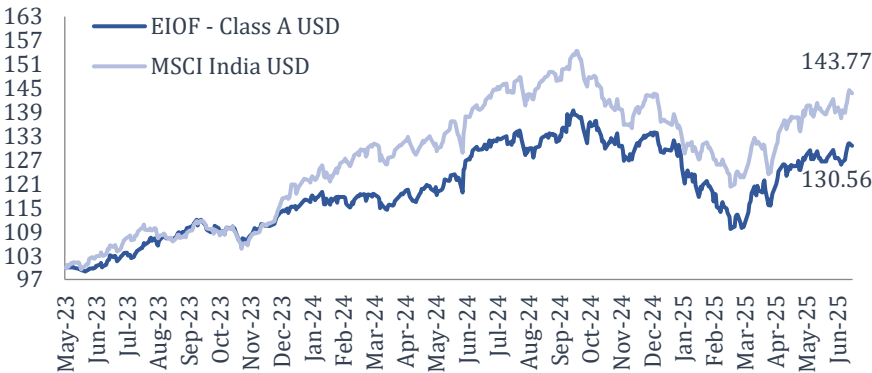

Growth of US\$ 100 invested



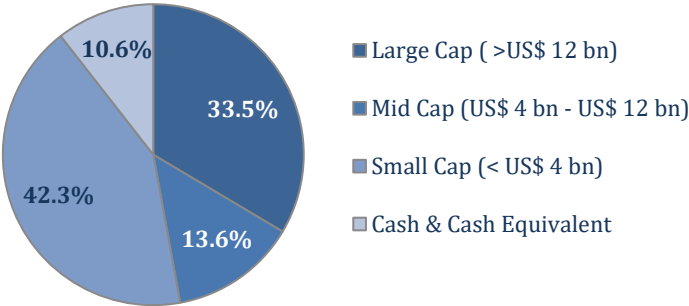

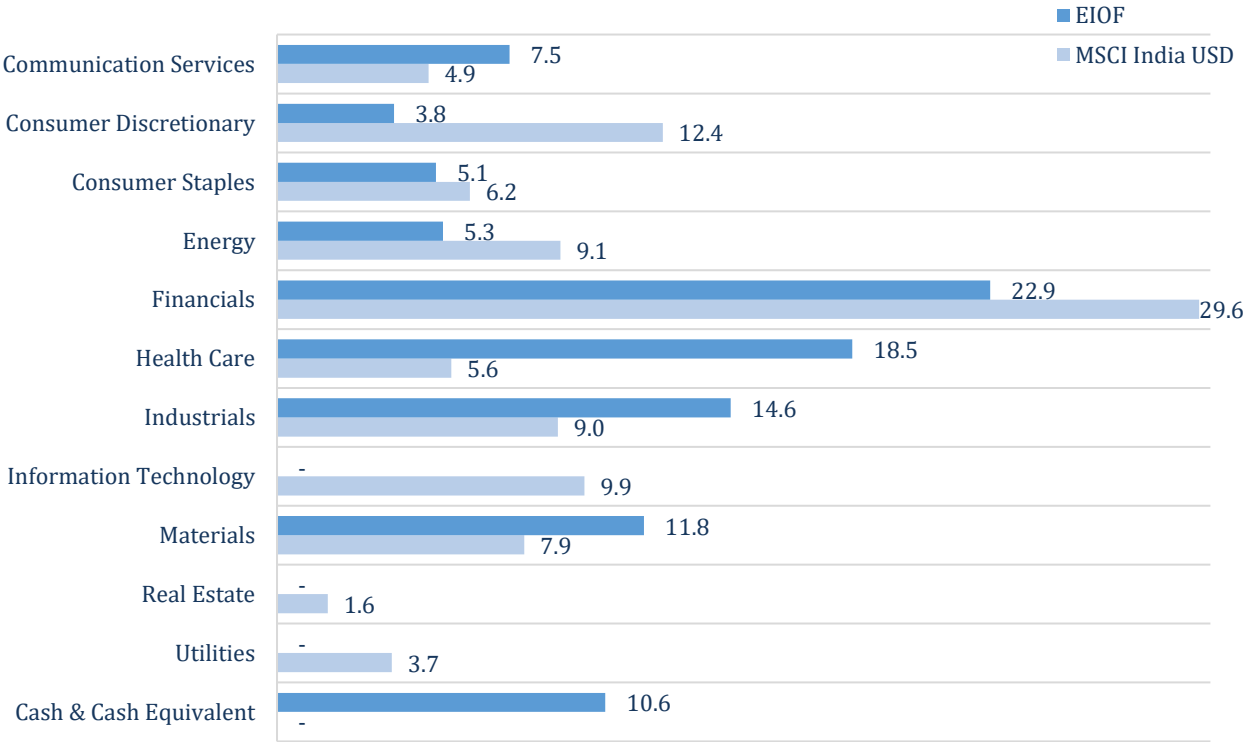
