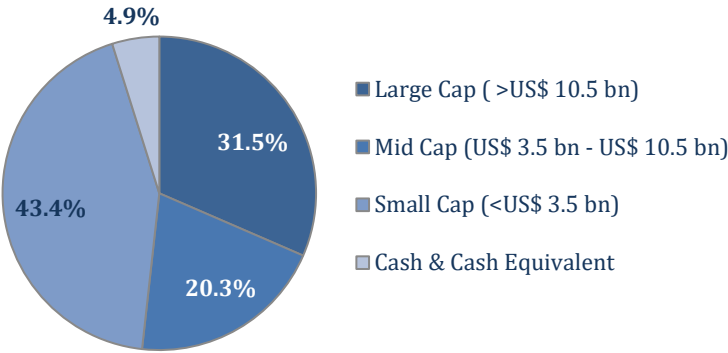

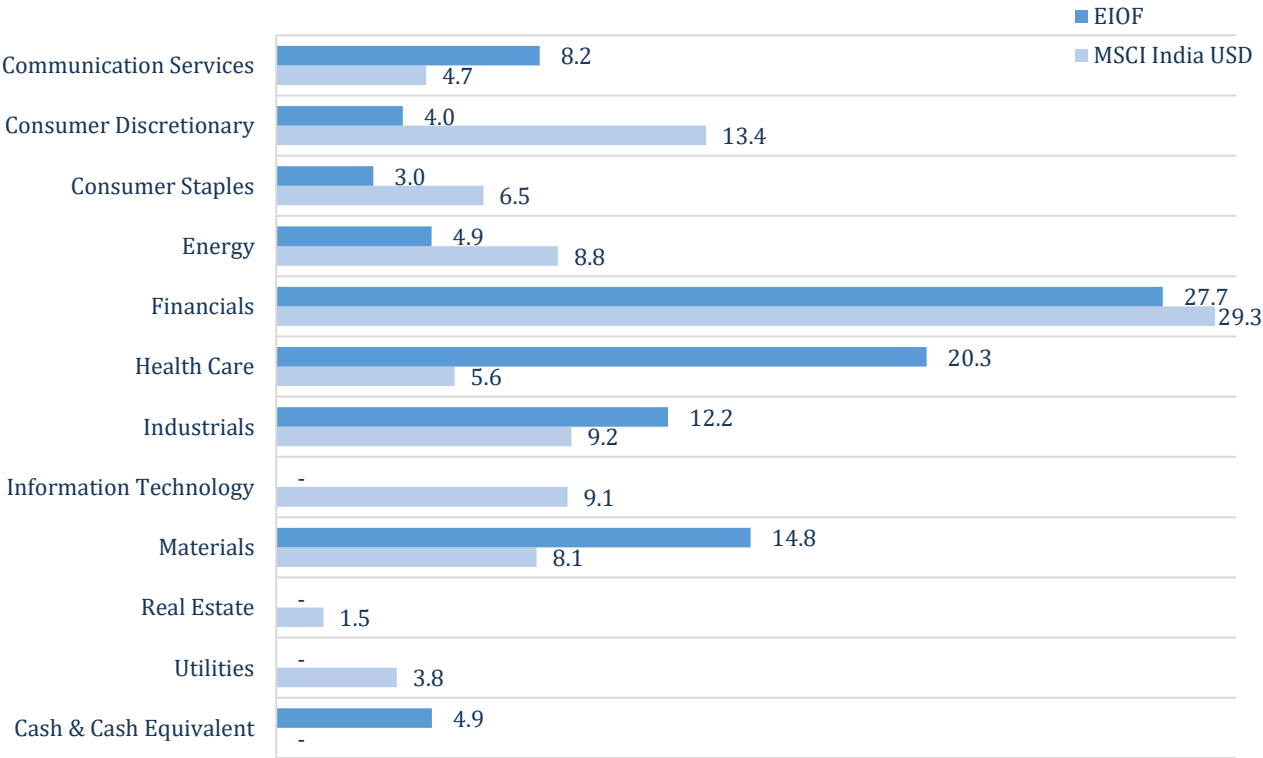
Market Cap Breakup
