Investment Policy

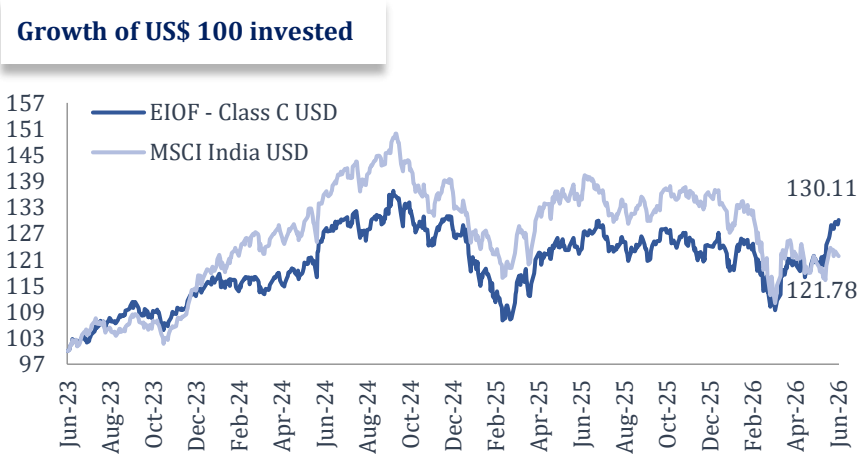
The Fund aims to achieve this investment objective by primarily investing in listed equity and equity-related instruments of Indian companies.

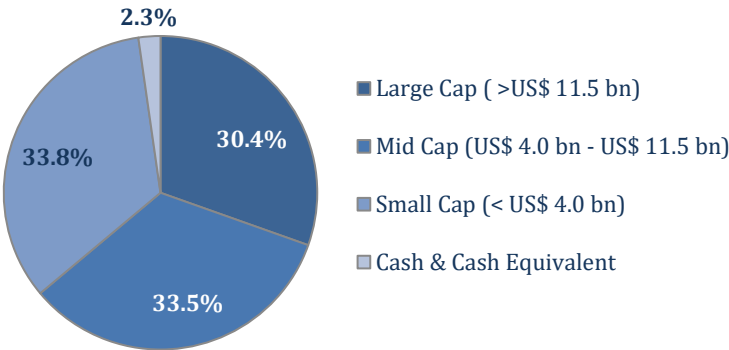

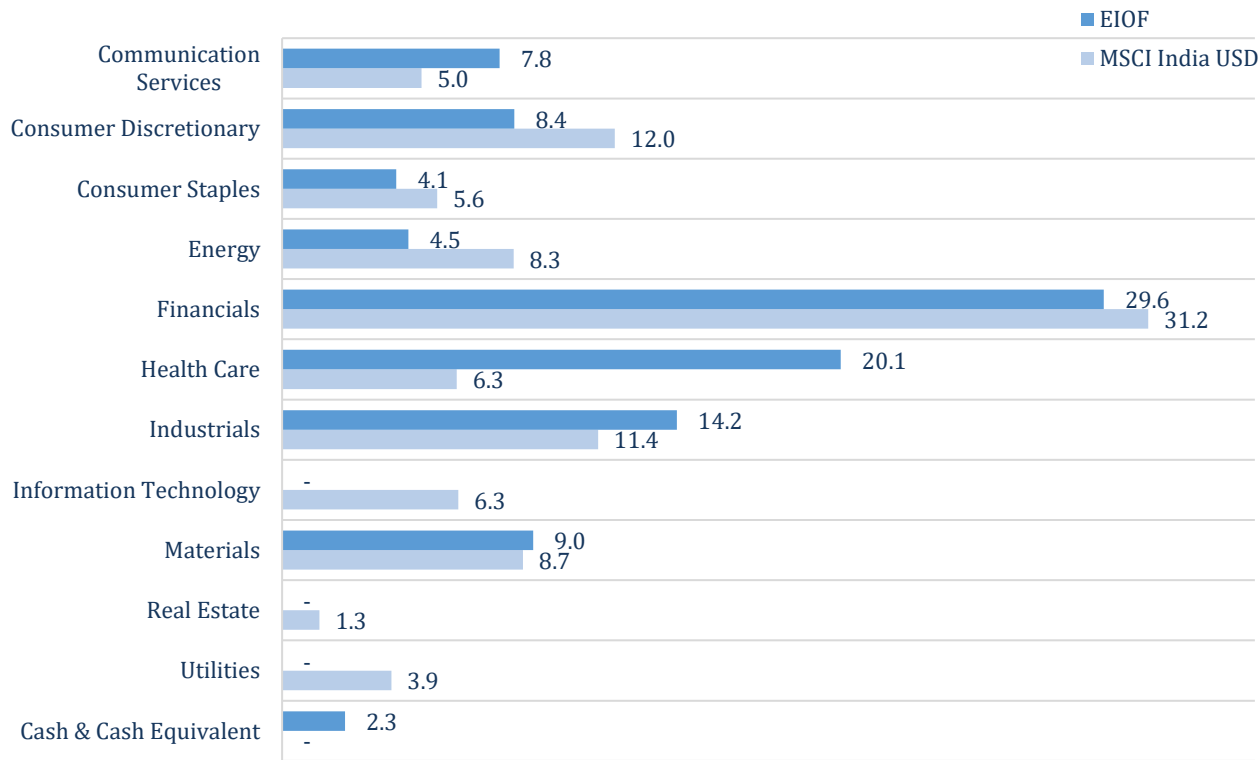
Market Cap Breakup
