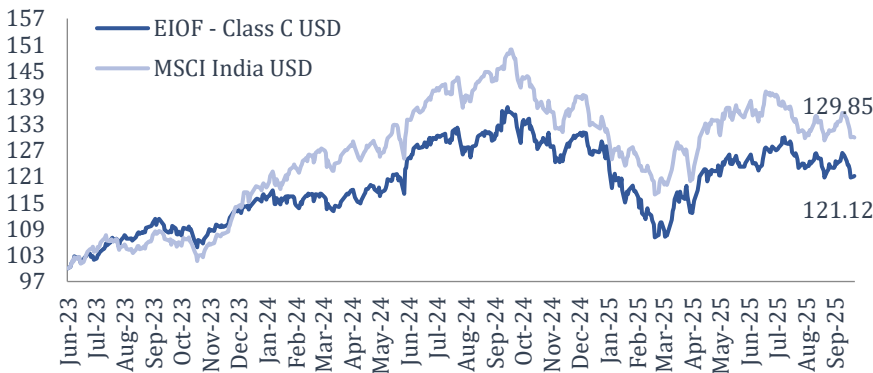

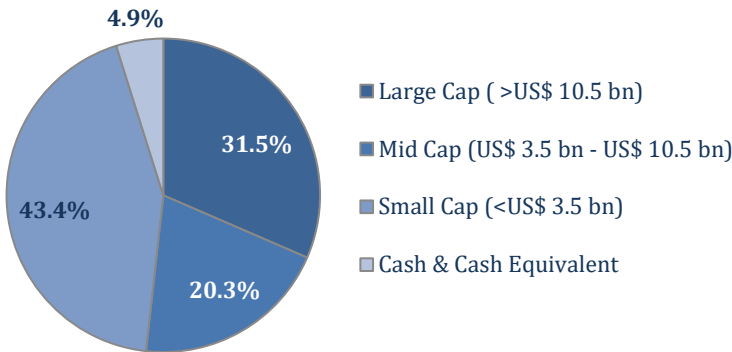

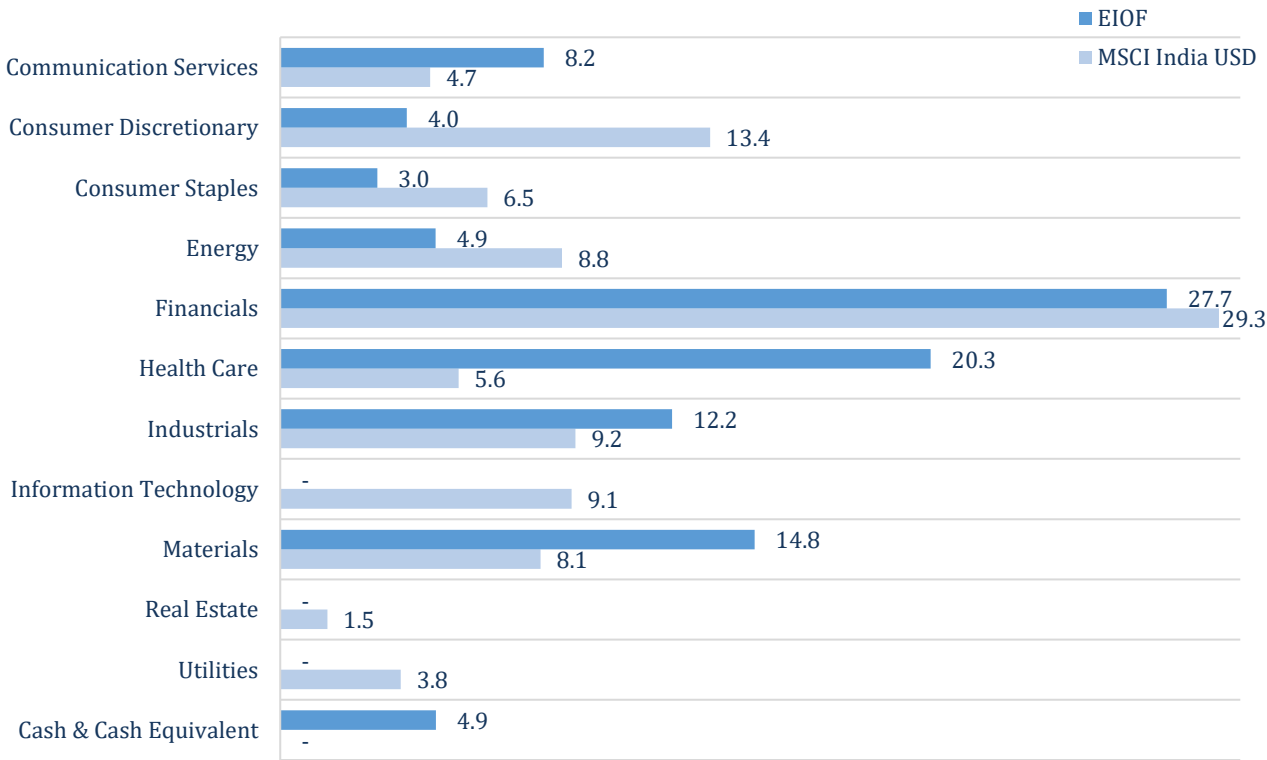
Market Cap Breakup
